ORDINANCE NO. 2010-05

AN ORDINANCE OF THE CITY OF HALLANDALE BEACH, FLORIDA, EXTENDING TO PEOPLES GAS SYSTEM, A DIVISION OF TAMPA ELECTRIC COMPANY, A NON-EXCLUSIVE GAS FRANCHISE THROUGH JUNE 30, 2010, UNLESS MUTUALLY EXTENDED BY THE PARTIES BEYOND JUNE 30, 2010, UNTIL A NEW FRANCHISE AGREEMENT IS BROUGHT BACK FOR CONSIDERATION BY THE CITY COMMISSION

WHEREAS, The City granted to Peoples Gas System, Inc. a non-exclusive franchise to operate and maintain a gas system within the City through a Franchise Agreement that was approved by the City as Ordinance 95-11 and accepted by Peoples Gas System, Inc; and

WHEREAS, Peoples Gas System, Inc., was acquired on or about June 17, 1997, by Tampa Electric Company and became a division of the same (hereinafter "Peoples Gas"), assuming the rights and obligations of Peoples Gas System, Inc., under the Franchise Agreement; and

WHEREAS, the Franchise Agreement approved by the City Ordinance 95-11 is set to expire on March 16, 2010; and

WHEREAS, the City, subject to written acceptance by Peoples Gas, may grant, renew, or extend the Franchise Agreement approved by Ordinance 95-11 until June 30, 2010;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA:

Section 1. The City Commission hereby extends the Franchise Agreement Ordinance 95-11 through June 30, 2010.


Section 2. All terms and conditions shall remain in full force and effect until June 30, 2010, unless mutually extended by the parties, with a new franchise agreement to be presented to City Commission for approval.

Section 4. This ordinance shall take effect upon adoption.
