RESOLUTION NO. 2013 - 41

A RESOLUTION OF THE MAYOR AND CITY
COMMISSION OF THE CITY OF HALLANDALE BEACH,
FLORIDA, APPOINTING COMMISSION MEMBERS AS
CITY REPRESENTATIVES TO THE BROWARD LEAGUE
OF CITIES, FLORIDA LEAGUE OF CITIES, AND THE
NATIONAL LEAGUE OF CITIES FOR THE 2013-2014
TERM; AND PROVIDING AN EFFECTIVE DATE.

11 **WHEREAS**, annually, the Mayor and City Commission appoint Officers/Directors,
12 Voting Delegates and/or Alternates to represent the City of Hallandale Beach at the
13 Broward League of Cities, Florida League of Cities and National League of Cities; and

15 **WHEREAS**, the Broward League of Cities designation will expire in May 2013,
16 accordingly the Broward League of Cities has requested each municipality to add an
17 agenda item for consideration by the second meeting in April 2013; and

19 **WHEREAS**, the Broward League of Cities' by-laws require that the Mayor and
20 City Commission appoint a Director, an Alternate and a Second Alternate to the Board of
21 Directors annually; and

23 **WHEREAS**, the Florida League of Cities' by-laws require the appointment of a
24 voting delegate and an alternate to attend and vote at the annual business session
25 annually; and

27 **WHEREAS**, the National League of Cities' by-laws require the appointment of a
28 voting delegate, and one (1) alternates, (if desired) to attend and vote at the annual
29 business meeting annually.

31 **NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY**
