RESOLUTION NO. 2012 - 07

A RESOLUTION OF THE MAYOR AND CITY COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA, AUTHORIZING THE CITY MANAGER TO AWARD RFP FY#2011-2012-001 TO SECURITY ALLIANCE, LLC TO PROVIDE SECURITY GUARD SERVICES FOR THE GOLDEN ISLES SAFE NEIGHBORHOOD DISTRICT AND THREE ISLANDS SAFE NEIGHBORHOOD DISTRICT; AUTHORIZING THE CITY MANAGER TO EXECUTE THE AGREEMENT WITH SECURITY ALLIANCE, LLC; AND PROVIDING AN EFFECTIVE DATE.

13 **WHEREAS**, In 2005, The City Commission awarded Navarro Group, LTD the
14 security services contract for the GISND and the TISND; and

16 **WHEREAS**, On October 1, 2011, the contract with Navarro Security, LTD.
17 expired; and

19 **WHEREAS**, On October 1, 2011, Navarro Security, LTD. was contracted to
20 provide temporary security services for the TISND and the GISND on a month-to-month
21 basis; and

23 **WHEREAS**, Eleven Security Firms responded to the Request for Proposals for
24 Security Services for the SND; and

26 **WHEREAS**, All the Proposals from the Security Firms were reviewed by the
27 Evaluation Committee; and

29 **WHEREAS**, the Evaluation Committee recommends awarding the Security
30 Services to Security Alliance, LLC.

32 **NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY**
33 **COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA:**

35 **SECTION 1. City Manager Authorization.** The Mayor and City Commission
36 hereby authorize the City Manager to award and execute the agreement with Security
37 Alliance, LLC, in substantially the same form as the Draft Agreement attached to this
38 resolution as Exhibit 2, to provide Security Services for the Golden Isles Safe
39 Neighborhood District and the Three Islands Safe Neighborhood District.




