RESOLUTION NO. 2016 - 161

**A RESOLUTION OF THE MAYOR AND CITY COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA, AWARDED BID #FY2015-2016-019, STORMWATER PIPE CLEANING TO THE SECOND LOWEST RESPONSIVE, RESPONSIBLE, BIDDER ENVIROWASTE SERVICE GROUP FOR AN AMOUNT NOT TO EXCEED FIVE HUNDRED SEVENTY EIGHT THREE HUNDRED TWENTY SEVEN (\$578,327.00) DOLLARS; AUTHORIZING A TEN PERCENT (10%) CONTINGENCY FOR UNFORESEEN CIRCUMSTANCES; AND AUTHORIZING THE CITY MANAGER AND CITY ATTORNEY TO NEGOTIATE AND TO EXECUTE AN AGREEMENT AND ALL RELATED DOCUMENTS TO EFFECTUATE THE PROJECT WITH ENVIROWASTE LLC; AND PROVIDING AN EFFECTIVE DATE.**

**WHEREAS**, pursuant to City Code of Ordinances, Chapter 23, Section 23-6 – Award of Contract, the City Manager shall have the authority to recommend to the City Commission award of contracts; and

**WHEREAS**, the City, like other cities, has an underground network of stormwater pipes that convey rain water to different lakes, canals, retention/detention ponds, and drains throughout the City; and

**WHEREAS**, the system is designed to move rain water from our streets in order to prevent flooding, which can cause property damage, pose a health risk to residents and cause personal injury; and

**WHEREAS**, to ensure that the system works as intended, it is critical that it is inspected, cleaned, and maintained on a routine basis; and

**WHEREAS**, in May, of 2016, A.D.A. Engineering, Inc. was contracted in order to generate stormwater pipe cleaning specifications, which would then be used to guide the firm that would eventually be contracted to perform the actual pipe cleaning; and

**WHEREAS**, on July 11, 2016, the City released the Invitation to Bid #FY2015-2016-019, Stormwater Pipe Cleaning. On July 20, 2016, a mandatory pre-bid conference took place, and twelve (12) prospective bidders attended; and

**WHEREAS**, on August 18, 2016, five (5) bids were submitted by the deadline for receipt of responses; and

**WHEREAS**, the Evaluation Committee reviewed the submissions. Although Hinterland Group, Inc. submitted the lowest bid, and Envirowaste Service Group provided the second lowest, responsive, responsible bidder bid, staff is recommending the award of Bid #FY2015-2016-019, Stormwater Pipe Cleaning to Envirowaste Service Group, because they hold an existing contract with a municipality in which they perform the exact scope of services, and Hinterland Group, Inc. submittal did not match the scope of services that the city is seeking; and

**WHEREAS**, the City Administration recommends that the City Commission award Bid FY #2015-2016-019, Stormwater Pipe Cleaning to Envirowaste Service Group for an amount not to exceed five hundred seventy eight thousand three hundred twenty seven (\$578,327.00) dollars; and recommend a ten percent (10%) contingency for unforeseen circumstances. The City Administration further recommends authorization for the City Manager and City Attorney to negotiate and execute an agreement with Envirowaste Service Group; and

**WHEREAS**, the Mayor and City Commission have determined that the City Administration's recommendations are in the best interest of the City and its residents.

**NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA:**


**SECTION 1. City Commission Action.** The Mayor and City Commission hereby award Bid FY #2015-2016-019, Stormwater Pipe Cleaning to the second lowest, responsive, responsible bidder, Envirowaste Service Group.

**SECTION 2. City Manager and City Attorney Authorization.** The Mayor and City Commission hereby authorize the City Manager and City Attorney to negotiate and execute an agreement with Envirowaste Service Group for an amount not to exceed five hundred seventy eight thousand three hundred twenty seven (\$578,327.00) dollars, and recommends a ten percent (10%) contingency for unforeseen circumstances. The City Manager is further authorized to execute all related documents to effectuate this project.

**SECTION 3. Effective Date.** This Resolution shall take effect immediately upon its passage and adoption.

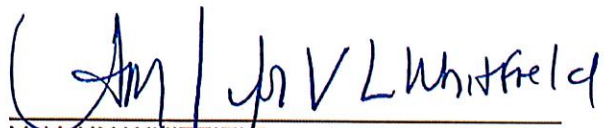
