**RESOLUTION NO. 2016 - 57**

**A RESOLUTION OF THE MAYOR AND CITY COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA, AUTHORIZING THE CITY MANAGER TO REJECT THE ONE (1) RESPONSIBLE BID #FY2015-2016-009 FROM V. ENGINEERING & CONSULTING CORPORATION FOR THE THREE ISLANDS REUSE IRRIGATION PROJECT; AUTHORIZING THE CITY MANAGER TO RE-ADVERTISE THE BID; AND PROVIDING AN EFFECTIVE DATE.**

**WHEREAS**, on February 12, 2016, the City of Hallandale Beach ("CITY") issued an invitation to Bid #FY2015-2016-009 Three Island Reuse Irrigation Project; and

**WHEREAS**, a pre-bid meeting and site visit were held on February 19, 2016, four (4) vendors attended the pre-bid meeting, and only (1) one bid was received; and

**WHEREAS**, after evaluation of V. Engineering & Consulting Corporation, it was determined that the vendor did not meet the minimum qualification requirements. The bid required the Contractor to have five (5) years of experience, however the vendor has only been in business since July, 2011; and

**WHEREAS, WHEREAS**, the lone bid from V. Engineering & Consulting Corporation was higher than the anticipated budget of eight hundred forty seven thousand seventy nine dollars and forty seven cent (\$847,079.47); and

**WHEREAS**, after further analysis and comparison of the vendor's submittal with the cost estimate that was performed by the Engineer of Record, it was discovered that the contractor's 8" PVC pipe cost was grossly high; and

**WHEREAS**, City Administration recommends that the Bid be reissued due to the fact that the City did not receive an adequate proposal during the initial bidding period; and

**WHEREAS**, the City Administration is desirous of rejecting the lone submitted proposal and re-issue a new Bid to receive an adequate amount of responsive, responsible bidders.

39 NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COMMISSION OF

42 **SECTION 1. City Manager Authorization.** The Mayor and City Commission hereby  
43 authorize the City Manager to reject the lone proposal received, and authorizing the City Manager  
44 to issue a new Bid to receive an adequate amount of responsive, responsible bidders.


