3 A RESOLUTION OF THE MAYOR AND CITY
4 COMMISSION OF THE CITY OF HALLANDALE
5 BEACH, FLORIDA, AUTHORIZING THE UTILIZATION
6 OF THE CITY OF OAKLAND PARK'S AGREEMENT
7 NUMBER R2019-070 FOR SANITATION CONSULTING
8 SERVICES of KESSLER CONSULTING, INC. FOR AN
9 AMOUNT NOT TO EXCEED SEVENTY-THREE
10 THOUSAND, ONE HUNDRED AND THREE DOLLARS
11 (\$73,103); AND PROVIDING AN EFFECTIVE DATE.

14 **WHEREAS**, pursuant to Chapter 23, Section 23-8 Exception to Bid
15 Requirements, (6) Bids and Contracts from Other entities, and Section 23-9
16 Cooperative Purchasing, the City Manager is authorized to procure all supplies,
17 materials, equipment and services from other governmental units, when the best
18 interests of the City would be served subject to the requirement that any purchase in
19 excess of \$50,000 requires City Commission approval; and
20

21 **WHEREAS**, the City of Oakland Park's competitively bid RFP No. 032919 for
22 Solid Waste Continuing Consulting Services resulted in a contract between Kessler
23 Consulting, Inc. ("Consultant") and the City of Oakland Park dated July 1, 2019 (the
24 "Source Agreement"), approved by the City of Oakland Park Resolution Number
25 R2019-070; and

27 **WHEREAS**, the City utilized the Consultant to review sanitation services and
28 prepare an RFP for multi-family and commercial collection; and
29

30 **WHEREAS**, the City Commission authorized Consultant on May 19, 2021,
31 through Resolution 2021-046, to revise the RFP document to include, as well, the
32 outsourcing of residential accounts pursuant to a change order to the scope of work
33 for a total amount of thirty nine thousand four hundred and fifty three (\$39,453); and
34

35 **WHEREAS**, staff recommends increasing the scope of work for the contract to
36 include additional procurement assistance, optional transition assistance and
37 technical services for a total contract amount Not to Exceed Seventy-Three Thousand,

38 One Hundred and Three Dollars (\$73,103).

40 **NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY**
41 **COMMISSION OF THE CITY OF HALLANDALE BEACH, FLORIDA:**

43 **SECTION 1.** The foregoing "Whereas" clauses are incorporated herein.

45 **SECTION 2.** The Mayor and City Commission hereby authorize the utilization
46 of the City of Oakland Park's competitively bid RFP No. 032919 for Solid Waste
47 Continuing Consulting Services with Kessler Consulting, Inc., and approve the
48 requested change authorization for a total contract amount Not to Exceed Seventy-
49 Three Thousand, One Hundred and Three Dollars (\$73,103); and authorize the City
50 Manager to sign all related documents.

52 **SECTION 3.** This Resolution shall take effect immediately upon its passage
53 and adoption.


